**Explanation of Responses:**

1. On January 12, 2017, the David D. Kim Trust of 12/31/87 sold 19,484,809 shares of the Company's Common Stock to a newly created Pennsylvania limited partnership, Sujochil, LP (the "Partnership"), at a price of \$10.8984 per share. Susan Y. Kim and John T. Kim are general partners of the Partnership. The limited partners of the Partnership are John T. Kim, Susan Y. Kim, two irrevocable trusts created by Susan Y. Kim for her descendants and two irrevocable trusts created by John T. Kim for his descendants. Susan Y. Kim and John T. Kim are the co-trustees of all four trusts.

2. The reporting person disclaims beneficial ownership of these securities, except to the extent of the reporting person's pecuniary interest therein, and this report shall not be deemed an admission that the reporting person is the beneficial owner of such securities, except to the extent of the reporting person's pecuniary interest therein, for purposes of Section 16 of the Securities Exchange Act of 1934, as amended, or for any other purpose.

Know all by these presents, that the undersigned hereby makes, constitutes and appoints Gil C. Tily and Jerry C. Allison (either of whom may act individually) as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:

(1) prepare, execute, acknowledge, deliver and file Forms 3, 4, and 5 (including any amendments thereto) with respect to the securities of Amkor Technology, Inc., a Delaware corporation (the "Company"), with the United States Securities and Exchange Commission, any national securities exchanges and the Company, as considered necessary or advisable under Section 16(a) of the Securities Exchange Act of 1934 and the rules and regulations promulgated thereunder, as amended from time to time (the "Exchange Act");
