- Reflects the distribution of 340,000 shares of the Issuer's Common Stock to Susan Y. Kim on June 16, 2023 by the Qualified Annuity Trust under the Susan Y. Kim 2020-1 Irrevocable Trust Agreement dated 4/1/20 (the "SYK Trust"). The Reporting Person's spouse is a trustee of the SYK Trust.
- On July 25, 2023, the JJK Trust distributed 443,811 shares of the Issuer's Common Stock to Susan Y. Kim. The Reporting Person's spouse is a trustee of the JJK Trust.
